President, Ross Iredale opened the meeting and welcomed everyone with particular mention to Life Member, Rod Roberts.

Ross advised the meeting of the following:

- Bowls Australia in 2019 advised Bowls NSW and Women's Bowls NSW that they expected them to start negotiations to unify bowls in NSW.
- An initial meeting was scheduled for January this year but unfortunately did not go ahead.
- Since then both the State Clubs have been working together and have met virtually
  to start to build toward what bowls could look like in NSW under a Unified State
  Body. This work is continuing with positive discussions in progress. The latest Joint
  Unification Update received early August advised that Sport Business Partners had
  been appointed to assist in facilitating this process.
- The information we all recently received from the WPH Sports Club that they are in talks to amalgamate with another Club, strengthens the need for a unified bowls body which will have a stronger voice than two smaller sections going forward.
- The Women postponed their Special General Meeting on Tuesday 25<sup>th</sup> August as their current Constitution requires Women's Bowls NSW to approve any changes to the Constitution. They are still waiting for this information back from State and as such tody we need to pass the circulated Constitution in principal on the understanding that any alteration Women's Bowls NSW deem necessary in the Constitution is included. An updated Constitution will be circulated to everyone prior to the Annual General Meeting.
