

4.10 Greens

"The Friendliest Club in the Hills"

As you will have noted, the bottom green is recovering well and it is planned to have it back in play within the near future. The plinths on the Western side need to be raised and there may be a small amount of plugging to take place in the North West corner. Even if this is required it will not stop the green from being used. As soon as the bottom green is available, maintenance on the top green will commence. It is possible that the bottom green may be taken out for one week in late January to give it a light dusting before the Pennant season commences.

Correspondence has been received from Hornsby Council re the gum trees. The Sports Club has been contacted and Jason has spoken to a representative of Council. It is hoped an inspection of the trees will take place shortly. A request has been made with Council for the Sports Club to have representation at the time of the inspection.

I have raised the question of repairs and replacement shades with Steve Brady. As you are aware, an email was sent to Steve approximately four weeks ago detailing the work required. Steve has confirmed that the repairs can commence. I will take the matter up with Ross Irwin.

The mower and "fatboy" have has been purchased by the Sports Club. Hopefully, the equipment in conjunction with the decision on the trees will improve the quality of the top green.

At the last meeting, we discussed the possibility of having a tifdwarf top green. The matter has been discussed with Ross Irwin. Even if we were in a position to receive approval from the Sports Club now, the green would not be ready for the 2013 Pennant season. I have received a rough estimate of the cost; however I wish to make some further inquiries. I hope to have more information at the time of the meeting.

Estimate of ~\$12k to convert top green to tifdwarf (Ross & Trent estimates) depending on where cost to dispose of soil.

Shades – repairs are progressing.
