#### 2013 Pennants:

Unfortunately the first round was washed out for all Grades. This Round will now be played on 6th April.

The Selectors are still 'fine tuning' Team selections in an endeavour to get the team mixes correct. With limited players available for Grade 3, our options are based on player availability and determining which players from Grade 5 can fill the gaps.

Grade 5 will also be reliant on player availability and where necessary, bring one or two players up from Grade 6. Our Reserve base is all predominately Grade 6 level.

Two Selectors will act as Side Managers for the Second Round and will report back to Michael and myself (Geoff unavailable until further notice due to ill health) on individual player performance. Ideally we would like to have two 'settled' Teams in each grade, but we will assess this on a week to week basis.

## 4.10 Greens

Finally there has been some movement relating to the trees. The Sports Club has been advised that the Parks and Gardens section of Hornsby Council will be or should have by now completed a second inspection of the trees. The first inspection which was carried out in Mid December 2012 by representatives of Council have completed their report and now it is the Parks and Gardens turn. Depending on the length of time it takes for the second report to be completed and subsequently agreeing with the first report, we may see some action in the future. Some of the Committee may have seen a large branch that came down recently. I would not have liked to have been underneath it at the time.

Both greens are now open for play. The wet weather that we have been experiencing recently has been of assistance in some respects. The bottom green has been freshened up sufficiently that it does not require it to be taken out of play for one week. The top green has come on well, however we have been experiencing warm days but not many warm nights. The top green needs to be treated carefully for the time being. Unfortunately, the continual wet weather has caused weed and fungus growth which is being treated.

The lack of water to the top green has been fixed with a new pipe being laid along the back garden bed. This pipe bypasses the old pipe allowing for an increase in water pressure.

A meeting has been held with Ross Irwin of Proturf re the installation of the Tifdwarf green. A request has been made for Ross to supply details of what is required, plus costs and a scope of works. If we move ahead on this project, we hope to be able to complete the task in the latter

part of 2013 in conjunction with the Sports Club alterations. Other quotes will also need to be supplied.

A quote has been received to replace seven shades. The cost will be approx \$4,300. The Sports Club is proceeding with the quote. As soon as the shades are ready, they will be installed. I have indicated that the replacement shades should be a capital expense against the Sports Club and not be a bowling sections expense. We will see what happens. The matter will again be raised with Keith Robinson.

The windsocks and corner flags have been replaced on both the top and bottom green.

The Koala WPH flag has just about reached the end of its days. It has been repaired on at least five occasions. Arrangements have been made with the Sports Club for a new flag to be obtained. It will be similar to the current flag, however the Koala logo will be altered to match the one appearing on the shirts and jackets. The new flag should be ready within the next two to three weeks.

New flag has been organised via Sports Club, using the new logo. Cost ~\$135+

New quotation received from Ross Irwin. PE has forwarded to Jason and will discuss with Geoff McIntosh once he returns.
