4.1 President

The Men's Section has been allocated from Zone 10, rounds of the Presidents Singles and Pairs competitions, which will be played during June. One of the reasons why we have been allocated the rounds is due to the excellent green keeping by Steve Arhipoff. Although, WPH has hosted the Presidents Singles in the past, WPH has not hosted the Pairs. West Pennant Hills also hosted a round of the Inter Zone Senior Fours on Thursday 2 May, an event that this club has not hosted in the past. Comments were received from the bowlers that the green ran well on the day. There were also comments that the green could have been better. I would say these comments came from bowlers who did not bowl well on the day. As it turned out, Zone 10 defeated Zone 9.

The Koala events for 2013 have been held. The weather was excellent for both the Women and well as the Men. Orange Blossom Carnival - Sat 14th Sept. Could we change this to Orange Blossom Challenge with the 5 Clubs sending 5 teams each with a grade 3 grade 5 and grade 6 (or Grade 7)in each team (as something different to a TAT) with aggregate scores (as with P/Hills Challenge) as an annual event. This may be achieved without prize money but as a Cup/Trophy being held by the winning Club? We already hold the \$100 from Hills Council. It could possibly be a Mixed event. (I thought of this prior to the recent Dural 'Super 6' invitations just received).

Set format – needs agreement of other clubs to change format. Too late for this year's event, could be changed for next year.

Bowls Co-ordinator Duties - I have had the time and facilities of handling this position to the best of my ability (and congratulations to those who have played this position in the past), however in my opinion the task is too heavy and would like to suggest that a position of *Carnival Co-ordinator* be appointed as a person who handles all carnivals (internal and external) and the *Bowls Co-ordinator* controls the Event Planner and Championship events only (obviously in partnership with the Carnival Co-ordinator). Next year I shall be absent for a month in Feb and a month also in Sept and could not do justice to being re-appointed in the current position, but would be delighted to be on the committee and assist in either of the 2 rolls I have suggested if required.

WP – suggests utilising the Match committee more, and if needed, increase size of Match committee.

Proposal has merit particularly for providing backup for Bowls Co-ordinator, and allows Bowls Co-ordinator to participate in carnivals.

Does Chairman of Selectors need to be formally part of Match Committee? Only for communication which can be achieved without need to be part of committee.
