The Directors of the NSWWBA and RNSWBA openly invite all NSW Bowling Members to review and provide feedback and comment on the proposed composition and distribution of Zones/Regions in the 'Bowls Zones/Regions in NSW' Discussion Paper, which has been commissioned as a joint initiative by the NSWWBA and RNSWBA to ensure that evidence-based and informed decisions can be made when planning for the future of the sport in NSW.

The Zones/Regions outlined in the paper are **not** final and have been proposed as an objective 'starting point' by an independent sports consultant using measurable criteria. As such, we welcome you to provide as much objective and measureable feedback/comments based on the criteria below to assist with this project.

Further comment: Certainly there is potentially more travel than present but as it is only once per year it is not a big issue.

Please feel free to make any further comment on the Boundaries Discussion Paper Q8 Following are our additional comments:

We have no issue with reorganising the Zones via council areas. After all there has to be some basis for any change.

A number of the areas (Councils) in the city are long and narrow and run north/south or east/west. Naturally it would be preferable if the areas were squarer. The trip from Wisemans Ferry to Five Dock is 72 kms and will take according to Google Maps 73 minutes to go one way. This is basically double the furthest distance we travel currently.

Brush Park is in Ryde Council and should not be in Area 14 if we are sticking with Council Areas. With the loss of Carlingford, Merrylands, Northmead, Toongabbie and Wentworthville Leagues, Area 13 is much weaker than currently under Zone 10. As mentioned before, the addition of the lower North Shore clubs adds nothing to the picture. With the exclusion of Carlingford and the addition of Brush Park, there are now only three Grade 1 clubs and 9 Grade 2 clubs. The addition of the Canada Bay clubs is not of much assistance either. From my understanding, the only club with any strength is Greenlees Park.

To take a broader view we would prefer to see the following removed from area 13 i.e. Hawkesbury, Lane Cove, Canada Bay, Willoughby and Hunters Hill. In return we would like to add Ku-ring-gai. This would turn area 13 into an area which is conveniently located for all clubs.
