4. Reports

4.1 President

Happy New Year! I hope all of you have enjoyed a break over the Christmas and New Year period and have returned fresh and ready for a big year of bowls.

I have been verbally advised on 29 December 2014 by Mr Read, the CEO of the Sports Club that the club will not be providing a BBQ for the bowling sections. While I believe that this represents a significant broken promise from the Sports Club and the Chairman personally, I cannot see any circumstances in which they will change their mind. I know that the Sports Club has been good to the bowling section in the provision of our new tiffdwarf green, however, I am exceptionally disappointed by this decision. Further, I cannot understand why food handling issues have suddenly become an issue and that the NSW Food Handling Authority states "People who are preparing food to be sold to raise money for charitable purposes (or the like) do not require formal cooking or food handling skills, provided the food does not pose a possible health risk or is eaten immediately after thorough cooking. They should have practical skills and knowledge appropriate to the type of food they are preparing to protect public health." It is my suspicion that this is being used as an excuse not to replace the BBQ. Mr Read advised the section will need to use the Restaurant for our catering. My

recommendation to the committee will be to double the catering budget to \$16,000 for financial year 2015/2016 to meet our catering requirements and to inform all members of the actions we have undertaken and the response from the Sports Club.

Mr Read also outlined why there is a difference in the men's and ladies annual membership fee, that is the ladies don't bowl as often. I argued that as the level of access to the green is the same, that is two dedicated bowls days per section plus mixed on Fridays and Sundays (and soon to be Saturday morning), the fees should also be the same.

I have been in contact with some local media outlets regarding advertising and will have more to report next month regarding this.

The Board has indicated a willingness to introduce a generous Junior Membership package and I will be asking the Membership committee to put together a proposal to go back to the Board. This will be presented at our next meeting.

As previously advised, the Competition Panel will make their recommendation regarding the number of pennant sides we should have in 2015 and the grades in which they compete. These are important decisions and I would ask Committee members to think of the section first rather than the effect these decisions may have on them personally.

I would remind all members of the Committee of the importance of confidentiality of our discussions and deliberation. This goes for all Committee matters and meetings. Further, any requests of the Men's section need to be lodged through the Secretary or myself to ensure the proper processes are followed. I have no time or sympathy for Committee members who wish to freelance and talk down the decisions taken by this Committee.

1.10 Greens Committee

The two weeks the top green has been out of play during the Christmas/New Year period, has been very beneficial. Areas of the green have been spiked with little cutting taking place allowing the grass to grow. The green has been watered extensively. The sections of the green damaged by the bowlers prior to Christmas have recovered and should not cause further concern.

It is planned that the top green will still be taken out of play for seven to ten days, after the bottom green is in use. At that time, the green will be cored and plugged and will also receive a light top dressing. The plugging will commence as soon as possible. Provided the weather is kind, the green should be in good shape for 2015.

Within the last week, the bottom green has been cut twice. The centre is covering over well and on the eastern side plugs have been used in the areas required. The green will also receive a further light top dressing. This may be the last top dressing depending on how the green looks over the next two weeks. At this time it is planned to have the green ready for play during the latter part of January. Ross Irwin is very happy with the progress of the green and will advise when the green is ready.

Whilst the top green is out of use, the Committee may need to consider if any restrictions will need to be applied to the bottom green. The matter has been discussed with Ross. The green surface will be soft at the start and will gradually harden over time. Weather conditions and watering will play a part. Roll ups, twilight bowls and Probus come to mind. What we don't want to see is damage similar to what occurred on the top green prior to Christmas as it is hard to repair and in the long term may cause problems during winter. The solution of course is to use mats though, I understand the last time this was considered a lot of ill feeling developed. I agree with Ross that the green is there to be used. We feel that we should take each week or day as it comes and make decisions if necessary at that time. The green will be rotated at regular intervals. Roll ups will be on the marker pegs. The top green will probably need to used more often for roll ups and training whilst the bottom green settles. There is no rush but the issue has been bought to the attention of the Committee.
