3.11 Greens Committee

As advised recently, Steve Arhipoff has resigned his position as green keeper at West Pennant Hills. He has decided to join his father on a building project at Port Macquarie. On behalf of the Committee as well as the bowlers at WPH, I wished him well for the future and thanked him for his commitment.

Cameron McClure has now joined us as the WPH green keeper. Cameron commenced his trade at Northmead and then spent six years at Merrylands and also Kingswood. Cameron is also a bowler playing at Northmead in Grade 2 having recently transferred from Toongabbie. This helps us at WPH as he has a good understanding of green speed and is able to consider this aspect accordingly. From a recent report presented to the Committee, Cameron will be targeting what was mentioned in the report, without putting undue stress on either of the greens.

We have had a 50% success rate with the Bent grass on the top green. It has taken well in the North/West corner, however in the South/West corner it has failed. Why this has occurred nobody has an answer. It has been suggested that we try again, though it is probably a little late. The area was plugged during the summer period and the Bent has not taken. At a guess it has something to do with the gum trees sucking the moisture out of the green. The area is in better condition than this time last year and we can certainly run 7 rinks North/South, though unfortunately only 6 East/West. When the green comes up for a major renovation later this year, the matter needs more consideration. The top green overall is running very well.

The bottom green, although it still has some imperfections is also running well considering the time the green has been in play. Cameron intends to take his time with the green and not rush it at this stage.

The two wind socks are now in place. I would like to thank Bob Cole for his assistance in positioning the wind socks on both greens.

This will be my last report on the greens for the time being. I will be undergoing surgery on 21 April and will not be in a position to bowl for a minimum of six weeks. This will be based on the success of the operation and if ongoing treatment is required. I will be able to visit the club within a couple of weeks after the operation and continue to take an interest in what is happening. The Committee needs to consider its options. I have suggested a course of action to the President and will leave the matter in his hands. I will inform Cameron and Ross Irwin accordingly.
