Ian Corke has published latest edition of *Koala News*. Copies have been printed and distributed and also available from website.


Minor improvements have been made to menu of blog.

4. General Business

- 4.1 20115/16 subcommittees David presented new sub-committee structure. (see attached). It is in the hands of the Chair to recruit members to achieve the goals of the sub-committee.
- 4.2 2016 Programme Programme had been circulated prior to meeting. No issues were raised. It was agreed to proceed. MS, GT
- 4.3 Twilight Bowls David had asked for volunteers to run the twilight bowls disappointed with low response. Events Committee to manage. DW
- 4.4 Aloha Bowls too late for 2015 consider for 2016.
- 4.5 Bowls jackets Geoff confirmed a delay in the order due to Hunter bowls not placing order with manufacturer. This has been rectified. Invoice for 50% of cost to be paid in advance

- 4.6 Bowls Cloths stocks are low. After discussion it was decided to not continue with bowls cloths as. Dallas to advise Women's section. DP
- 4.7 Business House competition Events committee to handle this as corporate event. DW
- 4.8 Bowls NSW 2016/17 Annual Membership Fees New fee structure for 3 years fixed based on number of bowlers in club mid 2015. The fee will not vary regardless of changes in membership. Fee for 2016 is \$5580 (inc GST).
- 4.9 A Frame entry sign a suggestion by Max to utilise signs outside club to direct visitors to rear entrance on days of early starts. Estimated cost for 2 units is under \$200 and it was agreed to proceed.
